5983	Oil (fuel) dealers - oil fuel	
9405	Government-to-government procurements — government only.	Deals between government institutions, departments, or agencies that participate in intergovernmental transfer programs (IGOTS).
9402	Postal services – government only.	Government postal services, including local post offices. Services include accepting and processing packages and mail for shipment, selling postage stamps, and express mail service. For postal stores providing packaging services and selling stamps, postcards, envelopes, which may also offer UPS services and other special postal services, use MCC 7399

9399	Government services, not previously classified elsewhere.	Merchants providing general government support services such as HR, audits, procurement, and building management services, and where not described by a more specific MCC. Examples include civil rights and empowerment fees, civil service offices, government accounting offices, general services offices, government supply agencies, police, fire departments, and vehicle inspection stations, as well as national, state, and municipal parks. For intergovernmental transfer (IGOTS) transactions, use MCC 9405. Merchants making sales of goods or services to the government should use the wholesale MCC that best describes the business.
9311	Tax payments	Local, state, and federal facilities involved in financial management and taxation, including the collection of taxes and penalties. These include customs offices and state tax fees.
9223	Collateral and payment obligations	Merchants who send collateral by mail to the court system to protect themselves from the appearance of involved private individuals.
9222	Penalties	Government institutions that manage and process local, state, and federal collections and penalties.

9211	Court-ordered payments, including alimony and child support.	Local, state, and federal courts, that administer and process court fees, alimony, and child support payments. For merchants that process fines or recoveries related to the court system, use MCC 9222.
9406	Government lotteries (excluding the USA)

7995	Gambling/Casino transactions.	Any transaction other than ATM transactions, including placing bets, purchasing lottery tickets, in-flight commercial games, or purchasing chips or other instruments in exchange for cash, goods, or services relating to gambling at establishments such as casinos, racetracks, card clubs, airlines, and the like. Acquirer shall identify all such gambling transactions with MCC 7995 so that the Issuer is fully aware of the nature of these transactions. Acquirer shall process remote gambling transactions in accordance with Sections 3.3.8.4 and 3-3-8.5 of the MasterCard Guide. For other types of purchases related to the establishment, such as food, lodging, or travel-related purchases, use the MCC that best describes the transaction.
7929	Musical groups, orchestras, and other entertainment services.	Services of musical groups, orchestras, theater groups, comedians and magicians, disc jockeys at discos, music for weddings.

7922	Theatrical production agencies	Production agencies, summer theater groups. This also includes theatrical and concert production, such as casting agencies, custom, stage and lighting services, and ticket agencies selling or booking tickets by phone.
7911	Dance clubs, dance schools, and studios.	Dance clubs, dance schools, ballrooms charging for lessons or admission. They offer dance lessons, ballet, ballroom, or other types of dance.
7523	Parking lots and garages	Companies providing temporary parking services for vehicles, with daily or monthly payment options. On a contractual basis or for a separate fee.
7519	Rental of recreational vehicles, accessories for land vehicles.	Rental of trailers, vans, box trucks, campers, and truck tarps for both short and long terms.
7513	Rental of trailer and truck accessories.	Leasing of equipment for trucks, vans, trailers.
7512	Rental of cars	Rental of cars.
7399	Business – service	Various business services. Examples include publishing companies, conference companies, meeting, event, and seminar planners, postal and packaging agencies.

7375	Information providers	Information technology providers, database information, internet provider services.

7372	Programming, data processing, integrated systems, design	Software-as-a-service, computer design, database processing on a contract or direct payment basis. Some may provide software design, system modification, data entry, and data processing services. User training.
7361	Employment centers	Employment center services with placement in temporary or permanent jobs.
7349	Cleaning and maintenance of premises	This includes cleaning services, building cleaning and maintenance, floor polishing, window washing, and office cleaning.
7339	Stenography and secretarial services	Stenography and other clerical services. Typing, editing, letter writing, summarizing, and preparing court transcripts.
7321	Consumer debt reporting agencies	Entrepreneurs specializing in compiling consumer debt reports, conducting investigations in this area, providing information exchange center services, and other related services.
6211	Securities – Brokers/Dealers	Payments charged by trading venues that sell, buy brokerage securities, commodities, and mutual funds.
6051	Non-financial institutions – foreign currency, money transfers (non-transferable), traveler's checks, quasi-cash.	For purchases of Mastercard money orders, foreign currency, money orders, or using Mastercard cards to open a deposit account at non-financial institutions. Any fee charged for purchasing such quasi-cash instruments (almost cash) and included in the total transaction amount shall be clearly communicated to the cardholder before the transaction is completed.

6012	Financial institutions – trade and service.	For trade purchases or services provided by financial institutions. Such purchases or services may include checks and other financial products, promotional items, loans, payment for references (advisory services). MCC 6211 is used for the secure payment of brokerage transaction services, or other similar expenses. MCC 6011 is used for cash withdrawals at ATMs.
6011	Financial institutions – automated cash withdrawal	This MCC is used to cash funds at automated devices, such as ATMs (at any type of financial institution).
6010	Financial institutions – manual cash withdrawal	Used only to identify personal transactions in which the cardholder uses Mastercard as a member of a financial institution to receive a cash payout, open a deposit account, or purchase traveler's checks, or save funds. MCC 6011 is used to cash funds at automated devices, such as ATMs. MCC 6051 is used for the sale of foreign currency, money orders, traveler's checks, or other quasi-cash items in locations that are not financial institutions.
5271	dealers of mobile buildings (?)	

5172	Oil and petroleum products	Wholesale supply of oil and petroleum products such as: butane, crude oil, fuel oil, petrol, kerosene, lubricating oils and greases, and naphtha (heavy petrol). This also includes providers of aircraft refueling services. MCC 5983 is used for retail sales of fuel oil, stove fuel, wood, coal, or propane.
4900	Utilities – electricity, gas, sanitation, water.	Direct generation, transmission, or distribution of electrical or gas energy, services for installing water supply systems, or collection and removal of waste. For retail outlets offering telecommunications services, MCC 4814 is used.
4789	Transport services – not classified elsewhere.	Retail points offering passenger transport services not classified elsewhere. These services include transportation by cabs or horse-drawn carriages, bicycle taxis, aerial cable cars, shuttle aircraft transport services, or funiculars. Excludes ferry services, bus transportation, cruise lines, passenger trains, and retail points offering taxi and limousine services.
4784	Road and bridge tolls, duties.	Trading venues collecting payments corresponding to road, highway, and bridge tolls.

4582	Airports, airport terminals, airfields	Sale points that manage and service airports and airfields. These locations may offer aircraft washing, aircraft maintenance and repair, aircraft storage at airports, and airport hangar rentals. For Sale points within an airport terminal selling food, newspapers, gifts, or souvenirs, use the MCC appropriate to that business, such as MCC 5812 (Eating Places and Restaurants), MCC 5994 (Printed matter dealers and Newsstands), or MCC 5947 (Gift, novelty, and souvenir Shops).
4468	Marinas, their maintenance and supply	Marina owners. Offered services may include slip rentals, boat storage, boat washing, minor boat repair, and retail boat sales. MCC includes establishments located at marinas that sell petrol for consumer use in boats, and those that do not have a separate merchant agreement other than with the marina. For gas stations located at a marina that have separate merchant agreements, use MCC 5541.
4457	Rental and charter of vessels.	Retail points primarily offering vessel rental and leasing, including fishing boats, bareboat cruisers, sailboats, powerboats, water skis, and yachts.

4214	Transportation agencies, local/long-distance freight transport, moving and storage companies, local delivery.	Local and long-distance freight transport, which may or may not provide storage services. MCC 4225 is used for storage of household goods and storage without transportation services. MCC 4215 is used for courier services for parcels, goods, and packages.
4131	Bus routes	Bus passenger transportation services operating on a regular schedule along a predetermined route. Use MCC 4722 for charter and tour bus operators.
4121	Limousines and taxis	Passenger transportation services in vehicles that do not operate on a regular schedule or predetermined route.
4111	Transportation – suburban and local seasonal vehicles, including commuter trains.	Providers of local and commuter passenger transportation services on regular routes and schedules, including seasonal rail transportation. Use MCC 4121 for taxis and limousines, and MCC 4131 for buses.
4011	Railways – freight transportation	Railways engaged in freight transportation. Use MCC 4112 for railways engaged in passenger transportation.
3000	Airlines, air carriers	This category corresponds to MCC codes from 3000 to 3299.

2791	Typing of texts, fonts, tables, and related services.	Sale points produce a diverse range of fonts and texts for the publishing industry and create clichés and templates for printing purposes. Examples of such services include typesetting of advertising texts, phototypesetting, automated-controlled typesetting and color separation, production of positives and negatives from which lithographic clichés and offset templates are printed; and engraving and embossing for printing purposes, such as wood engraving, rubber, copper, steel, or photogravure. MCC 2741 is used for sale points that primarily provide a variety of printing services.
1520	General contractors – residential and commercial construction	General contractors are primarily involved in the construction of residential and commercial buildings. Construction services may include new construction, renovation, repair, additions, and remodeling.
5933	Microloans, Financial Services, Pawn Shops, Payment Terminals	Pawn Shops
4829	Microloans, Financial Services, Pawn Shops, Payment Terminals	Money Transfers

763	Agricultural cooperative societies	Associations and cooperatives offering farm management services or assistance with farm work. Examples of such services include financial assistance, management or full support for crop care, soil preparation, planting and cultivation, aerial pollination and irrigation, disease and pest control, weeding, and harvesting. MCC 4225 is used for sale points offering farm commodities for warehousing and storage.
